# Infobeans Sports Championship 2025 - Cricket Rule Book & Schedule

#### **Tournament Overview**

• Format: 8-over matches (League) Final - 10 Overs (Subjected to time availability)

• Teams: 4 Teams (Alpha Squad, Team Beanstomer, Team Jaguar, Vijayi Warriors)

• Team Size: 16 Players (16 Male)

Match Type: Tennis BallVenue: AKPC Cricket Ground

• Dates: 13 Dec 2025

#### **Tournament Format**

• League Stage: Each team will play two matches.

• Points System: Win – 2 Points | Tie / No Result – Super Over | Loss – 0 Points

• Final: Top 2 teams on the points table will play the Final.

• If points are equal, Net Run Rate (NRR) will decide the finalists.

### **Team Composition Rules**

- Squad Limit: 16 players (11 playing + 2 substitutes+3 Bench).
- **Impact Player Rule:** One Impact Player can be substituted. The replaced player cannot take further part in the match (bat/bowl/field). Only players from the announced 13-member squad can be used as Impact Player.

### Match Rules\*

- Each innings consists of 8 overs for league matches and for Final 10 Overs\*
- Powerplay: **First 2 overs** only 2 fielders allowed outside the 30-yard circle. After that 5 players are allowed outside the 30-yard circle.
- Bowler Restriction: only one bowler can bowl a maximum of 3 overs (for finals max 2 bowlers can bowl 3 overs each)
- No Ball & Free Hit: Applies as per standard cricket rules.
- Wide ball = 1 run, and the ball to be re-bowled.
- No ball = 1 run + Free Hit next delivery.
- Overthrows count as additional runs.
- LBW are not allowed.

## **Powerplay Rules for the Final Match**

# 1. Bowling Powerplay:

- The first **2 overs** of the innings will be a **mandatory bowling powerplay**.
- During these overs, **only 2 fielders** are allowed outside the **30-yard circle**.

#### 2. Batting Powerplay:

- Each team will have 1 batting powerplay over, which the batting side may choose at any time during the remaining overs (after the bowling powerplay is completed).
- During the batting powerplay, only 3 fielders are allowed outside the 30-yard circle.

#### **Tiebreaker Rules**

- During League Stage: Higher Net Run Rate (NRR), Head-to-head result
- In Case of a Tied Match: Super Over will decide the winner. Each team will nominate 3 batsmen and 1 bowler. If still tied, Super over continues till the result is obtained.

## **Timings & Conduct**

- Teams must report 15 minutes before the match starts.
- Toss to take place 10 minutes prior to scheduled start time.
- Late arrival penalty: 0–10 minutes opponent gets to choose bat/bowl. Beyond 15 minutes match may be forfeited.
- Umpire's decision is final.
- Spirit of the game to be maintained throughout. Misconduct or foul language will lead to suspension from the match.

#### **Match Duration & Penalty Rule**

#### • Total Match Duration:

Each match must be completed within **1 hour and 15 minutes**.

- Each Inning should be completed within **35 mins**.
- Penalty for Delay:

If a team fails to complete the match/Inning within the stipulated time, they may be **penalized with fair-play point deductions or run penalties**.

• Decision Authority:

The **on-field Match Umpires** will determine and apply the appropriate penalty **in real time during the match**, based on the situation and reason for delay.

#### **Safety & Fair Play**

- No intentional targeting, sledging, or aggressive behavior allowed.
- Respect fellow players, umpires, and organizers.
